## ESG

In 2022, California lawmakers passed a series of climate-related bills. Assembly Bill 1279 reiterated the state's plan to reach carbon neutrality by 2045, and building off Senate Bill 100, California Senate Bill 1020 has a target of 100% renewable and carbon-free electricity economy wide by 2045.

But as the San Diego region faced the possibility of blackouts during the summer of 2022 due to grid-related strain from heatwaves, storms, and wildfires, it leaves some to wonder how the state will achieve its stated goals.

During this session, representatives from San Diego Gas & Electric (SDG&E), San Diego Community Power (SDCP), and the County of San Diego will discuss efforts underway to harness regional ingenuity and help meet state goals.




